

All Gifts Have an Impact

A gift of any size to the University can make a big difference. Thousands of individual gifts are pooled together to provide scholarships, support research, offer enrichment activities to students, and so much more. In 2010, donations of less than \$250 collectively totaled more than \$1.7 million for UConn.

- 25 gifts of \$25 will purchase two cases of test tubes for a laboratory classroom
- 85 gifts of \$50 will provide one semester of a weekly "special night" program in a residence hall
- 100 gifts of \$125 will support an Academic Excellence Scholarship for a deserving student
- 4 gifts of \$250 will support the Global Leadership Commission (GLC), a student group that brings renowned leaders in their fields to campus to speak at UConn
- 5 gifts of \$300 will hire three faculty members or PhD students to teach 1-credit Learning Community seminars
- 8 gifts of \$500 will support student summer research (SURF) or creative projects
- 5 gifts of \$1,000 will allow the Animal Sciences department to hire summer interns, providing both needed labor and practical job experience
- 10 gifts of \$2,500 will send 50 students on an alternative spring break trip to the Gulf Coast for community service experiences

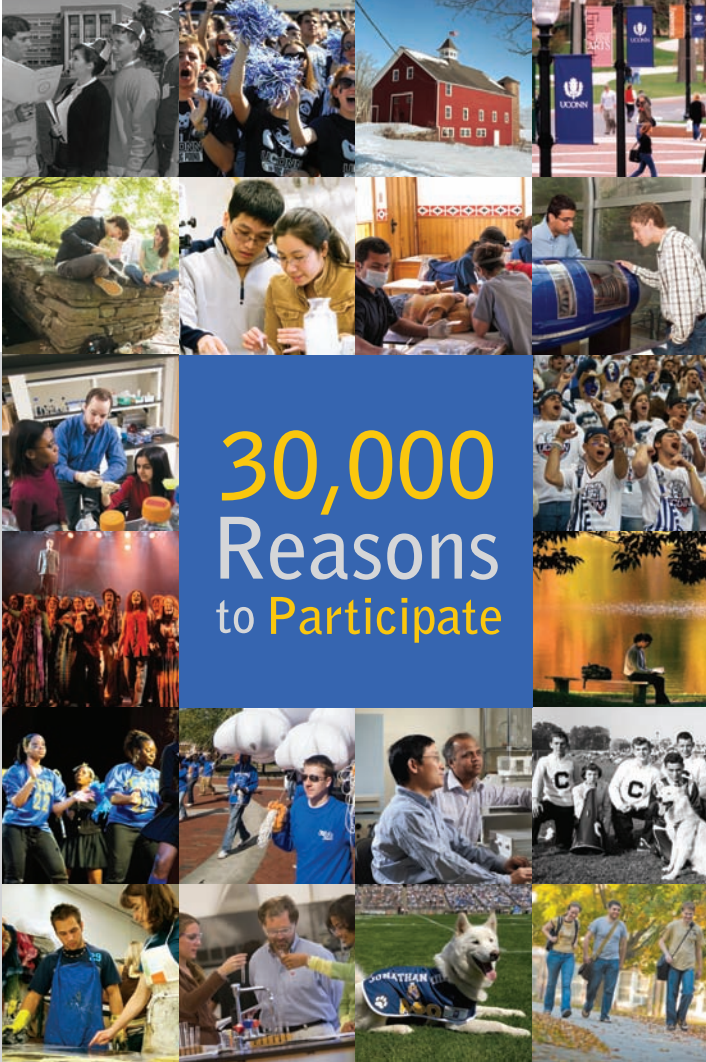
